

## MEMORANDUM OF COOPERATION

In Mytilene today on 2022, March 1 the parties:

A. The Civil Non-Profit Company with the name "ARIADNI AMKE" and with the distinctive title "ARIADNI A.M.K.E" for the international relations, with base in Mytilene (11 Katsakouli str.), with Tax Identification Number 996655078 and number of General Commercial Record 162750542000, legally represented for the signing of this by Ms. ZEDNICEK (surname) URSULA MARIA (name) resident of Bonn, Germany (Johannesstrasse 35 Bonn 53225 Germany) temporarily residing in Mytilene (11 Katsakouli str.), with German Police Identification Number L73Y7LKFF and Tax Identification Number 159472154.

B. The Civil Non-Profit Company with the name "Hoffnung leben e.V." and with the distinctive title \_\_ "Hoffnung leben e.V." \_\_ for the international relations, with base in Bonn (Johannesstr. 35), with Tax Identification Number 206/5865/1209 and General Commercial Record Number VR11591, legally represented for the conclusion of this by Ms ÜBELHÖR (surname) EVA MARIA (name) exclusion, through employment and personalized counseling to vulnerable groups of the population. It was founded and operates from 25.02.2022.

"ARIADNI AMKE" is based on transparency and accountability. "ARIADNI AMKE" has established operational policies to combat fraud and corruption and to ensure the proper use of the funding it receives.

Respectively, "Hoffnung leben e.V." has according to its founding statutes similar purposes, namely:

1. The association pursues exclusively and directly non-profit purposes in the sense of the section "tax-privileged purposes" of the tax code. The purpose is to promote aid to refugees.
2. The association is independent from political and religious view points and will co-operate with everyone who also pursues purposes that correspond with those of the association.
3. The purpose of the association is to bring together people of different origins and backgrounds - "locals" and "refugees" - and to enable them to experience and learn about living together respectfully and peacefully.
4. The purpose is also to strengthen individuals on a mental, spiritual, physical and social level, i.e. their health in the broadest sense, and thus mitigate the consequences of trauma after war, violence, flight, crime, inhumane accommodation and social isolation.
5. This shall be achieved in particular by creating opportunities for joint employment and learning with and from each other in a safe and relaxed environment e.g. in intercultural arts and crafts groups in line with the purpose of the association.

6. The association advocates the inalienability and observance of human rights according to UDHR (Universal Declaration of Human Rights 1948) and the ECHR (European Convention on Human Rights 1953)

Already today, the Contracting Parties agree to cooperate within their respective spheres, in any appropriate way, and support one another mutually accepting the following:

1. The Parties recognize the need to strengthen through their cooperation the services provided, in order to effectively support the island's people who belong to socially vulnerable groups (refugees, homeless, destitute, people on the brink of extreme poverty) and generally need help and solidarity, with the ultimate goal of improving their quality of life.

2. With a joint decision of the parties and with the observance of the respective legal procedures, "ARIADNI A.M.K.E." may be designated as the implementing body of specific programs and actions. These programs should specify the object, the form of funding and the framework for their implementation. The common goal of the parties is to seek sources of funding (local or national), to claim national or European funding programs, to seek funding programs, donations from Foundations, etc.

3. The parties agree and accept the observance by all parties of all legal procedures and regulations in general that will govern the completion of the programs being implemented. The cooperating parties are committed, for the most effective implementation of the objectives of the present, to cooperate, to perform and to fulfill all the obligations of it in time and in good faith.

4. The Contracting Parties may co-decide on a partnership with other bodies of their choice to achieve the objectives of this Memorandum/Protocol of Cooperation.

5. It is expressly agreed that the use of the facilities of "ARIADNI AMKE", by executives, volunteers, employees of \_\_ "Hoffnung leben e.V." \_\_, will be free of charge. In return, "ARIADNI AMKE" can also use the facilities of "Hoffnung leben e.V." accordingly free of charge.

6. The joint design, financing, execution of programs of action to fulfill the common objectives, may include, in addition to the use of the facilities, as above, the lending of employees - volunteers - executives, which will be subject to the provisions of the Greek legislation.

7. The costs for activities and projects of ARIADNI AMKE will be financed through the bank accounts of "ARIADNI MAKE".

8. Hoffnung leben e.V. supports Ariadni in activities that offer opportunities for people of different origins (refugees, locals, etc.) to get to know each other through joint activities and to learn with and from one another. Hoffnung leben e.V. also supports activities that impart education, knowledge and skills that prepare for an independent

life in Europe and thereby address the main causes of flight (war, poverty, climate change, environmental destruction) and address countermeasures.9. As per the end of February / early March, each year, an annual report is sent from "ARIADNI AMKE" to "Hoffnung leben e.V." accompanied by all the invoices, receipts and expenditures made on the preceding common projects.

9. As per the end of February / early March, each year, an annual report is sent from "ARIADNI AMKE" to "Hoffnung leben e.V." accompanied by all the invoices, receipts and expenditures made on the preceding common projects.

10. This MoC is valid until it is terminated by one of the above parties, only for serious cause, according to the Greek legislation.
